### President's Report Henry G. Sanchez

Since the start of my presidency in January 2004, I have been determined to help our chapter become a vibrant and active organization where people can learn about the global challenges facing the UN. At the same time, I wanted our chapter members to engage more with young professionals, visit various missions and consulates, and commit ourselves to the long-term health of our organization. I can report with great pride that we have had an incredibly successful year! Membership is up. We have visited both the Hungarian and Canadian Consulates. And we have invited the New York chapter of Young Professionals for International Cooperation—YPIC—to become involved with our organization (see page 5).

This year marks the 60th anniversary of the UN. Our programs and activities will reflect this momentous time and are designed to highlight the Millennium Development Goals to combat poverty, hunger, disease, illiteracy, environmental degradation, and discrimination against women.

At the same time, we look forward to an agenda that will give members the opportunity to socialize through art and cultural events. We were very happy to help the YPIC host a film festival in December. We are planning future film screenings at various venues, as well as an art exhibition in the lobby of the UN.

Once again I want to thank UNA-NY's board for the opportunity of serving as your president in 2004 and I look forward to doing so in 2005!

## Egeland Presentation Launches 2005 Programs

On January 13, UN Under Secretary General and Emergency Relief Coordinator Jan Egeland spoke to an audience of over 150 UNA-NY members and guests at the UN Church Center auditorium.

His topic, "The Tsunami Crisis in Asia and Africa: The World Responds," covered the extraordinary natural disaster at the end of 2004 and the subsequent reactions and strategies of UN agencies, governments and NGOs around the world.

He reprised the situation which has so far taken the lives of an estimated 150,000 people in twelve countries. Millions have been displaced and many tens of thousands are missing.

> "Today we are having an unprecedented challenge in so many countries," Egeland told the standing-room-only group. "I am acutely aware that the eyes of the world are upon us—we must prove we are a united nations. And yes, we are responding as united nations." And because the United Nations currently has humanitarian programs in over 100 countries, its local workers were first on the scene of the crises in Asia and Africa.

The UN effort, with Mr. Egeland at the lead, continues a monumental coordination of over 100 local governments, 150 NGOs, military assistance from 15 countries, and tens of thousands of volunteers.

UNA-NY has researched and developed a proposal to create an engaging interactive DVD introduction to the United Nations. Our chapter is seizing the opportunity to use this popular technology to tell the United Nations story in a powerful format.

As soon as we secure funding, we're prepared to complete DVD production in 2005, in time for the UN's 60th anniversary. We plan to disseminate copies to US libraries, make them available to UNA chapters, and distribute them for sale in UN bookstores throughout the world!

The primary audience for our DVD will be the American public. The introduction will explain how President Franklin D. Roosevelt conceived the idea for the UN and ensured that representatives from countries around the world would attend the 1945 San Francisco convention. This convention successfully established what is today the only multilateral worldwide security organization. Interactive scenarios based on UN events will present the complexities involved in global issues such as public health, peacekeeping, trade, and the environment.

An award-winning production company has been selected to produce the DVD. They have extensive experience in developing materials for museums and other educational institutions.

## MoMA to Screen Jonathan Demme's Film, "The Agronomist"

The **Communications Committee** has been planning a film series to build support for the United Nations among young people, especially college students. The first event in the series is "The Agronomist," a documentary about Haitian national hero, journalist and freedom fighter Jean Dominique and directed by Jonathan Demme. The event will take place at MoMA on April 7 at 8 pm.

Jonathan Demme will introduce and discuss the film along with Jean Dominique's widow, Michele Montas. The event is co-sponsored by our chapter and Fairleigh Dickinson University.

As owner and operator of his nation's oldest and only free radio station, Radio Haiti Inter, Dominique was frequently at odds with his country's various repressive governments and spent much of the 80s and early 90s in exile in New York, where Demme met and interviewed him over the years. Dominique fought tirelessly against his country's overwhelming injustice, oppression, and poverty. But it was Dominique's shocking and still-unresolved assassination in April of 2000 that gave the director the impetus to assemble more than a decade's worth of material into a celebration of this dynamic man and his legacy.

The film will be offered to college students from Fairleigh Dickenson University whose Associate Provost of Interdisciplinary, Distributed and Global Learning Michael Sperling has established the contact with Jonathan Demme. UNA-NY members and students from local New York universities are encouraged to participate.

The aim of these film festivals is to introduce students to issues the UN faces globally. This film focuses on human rights. Future events will feature films focusing on global UN issues. Our chapter looks forward to widening the audience for these events with students across the city.

This year's opening program on January 13 featured UN Under-Secretary General for Humanitarian Affairs Jan Egeland, the UN's coordinator for emergency relief and drew an audience of well over 150 (see page 1).

Our Annual Meeting at the Helmsley Palace Hotel was attended by over 140 people. Our guest speaker was the distinguished Professor Jeffrey Sachs, director of the Earth Institute at Columbia University and special advisor to the Secretary General on the Millennium Development Goals (MDGs).

In September, Clyde Prestowitz, author of the bestselling book Rogue Nation, spoke to our group about the historical roots of American

unilateralism in foreign policy.

In November, Stephen Schlesinger, director of the World Policy Institute at the New School, discussed Latin America and various Latin

American governmental strategies—democracy in contrast to authoritarian regimes or revolutions. Our December program was in collaboration with

UNIFEM on "Gender Justice in Post-Conflict Situations."

Programs on Africa, the water shortage facing our world, and many other pertinent topics will be featured in 2005.

Our annual meeting is planned for May 24 at the Polish Consulate.

## New York's Young Professionals for International Cooperation Initiate Programs

The United Nations Association's Young Professionals for International Cooperation (UNA-USA YPIC) is a nonpartisan, national network of professionals ages 21 to 40 who work to promote effective US involvement in international affairs and in the UN. As part of the United Nations Association of the United States of America, YPIC provides emerging leaders access to resources and contacts that allow them to act on issues of national and global importance. In May, 2004, the board of UNA-NY approved the creation of a local YPIC to outreach and recruit UNA-NY members from New York City's vast population of dynamic young people.

New York's YPIC had its first event on Wednesday, October 20, featuring our Global Issues Speaker Series. The speaker was Gillian Sorensen, senior advisor at the United Nations Foundation, who spoke on the relationship between the UN and the US.

On November 10, we continued our Global Issues Speaker series with John Washburn, convener, American Non-**Governmental Organizations Coalition** for the International Criminal Court, who spoke about the ICC and possible US reactions to an active court. Also in November, we participated at UNA-USA's outreach to students and young professionals hosted at the UN. On November 13, over 200 young people, some from as far away as Nevada, came to hear a panel of speakers which included Stephen Schlesinger, director of the World Policy Institute, and Ambassador Patrick Havford, director African Affairs, Executive Office of the Secretary General.

On December 10, International Human Rights Day, UNA-NY co-hosted a UNA Film Festival entitled "The Values of Tolerance" with the YPIC. The film festival was held at the New York Film Academy and it was a great success with over 100 people attending.

In 2005, along with our normal monthly events, YPIC will be highlighting the Millenium Development Goals (MDGs). Ambassador Ahmad Kamal, former Permanent Representative of Pakistan to the UN and current President and CEO of the Ambassador's Club, kicked off our series on January 12.

Currently, UNA-NY YPIC has five committees that are issue-driven and/or regionally focused. They are: economic development; European affairs; global health; human rights; and Latin American affairs.

coordinate, and distribute transparently the 5 billion dollars in pledges from over 60 donor nations. "The response has been exemplary," Egeland told his audience during a question and answer session. "The US reaction was exemplary." Plans are also underway for a world conference on disaster reduction and early warning systems.

In closing, Mr. Egeland told his audience that his biggest challenge in the coming months is to transfer this "enhanced spirit of humanitarian generosity" to "forgotten emergencies" and ensure that funds will not be taken away from ongoing crises, especially the AIDS crisis in Africa. "If we believe a life is equally important in Africa as it is in Kosovo or Banda Aceh, we must give in equal proportions."
